Currently, 75.9% of the 44,432 housing units in the area are owner occupied; 21.8%, renter occupied; and 2.4% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.3% are renter occupied; and 11.3% are vacant. In 2010, there were 35,248 housing units in the area - 72.8% owner occupied, 21.7% renter occupied, and 5.5% vacant. The annual rate of change in housing units since 2010 is 10.84%. Median home value in the area is \$180,818, compared to a median home value of \$235,127 for the U.S. In five years, median value is projected to change by 2.22% annually to \$201,761.
