Currently, 55.4% of the 79,736 housing units in the area are owner occupied; 36.7%, renter occupied; and 7.9% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.3% are renter occupied; and 11.3% are vacant. In 2010, there were 67,980 housing units in the area - 56.8% owner occupied, 35.0% renter occupied, and 8.1% vacant. The annual rate of change in housing units since 2010 is 7.35%. Median home value in the area is \$200,271, compared to a median home value of \$235,127 for the U.S. In five years, median value is projected to change by 3.56% annually to \$238,508.
