In the identified area, the current year population is 253,091. In 2010, the Census count in the area was 223,227. The rate of change since 2010 was 1.23% annually. The five-year projection for the population in the area is 266,562 representing a change of 1.04% annually from 2020 to 2025. Currently, the population is 48.8% male and 51.2% female.

The median age in this area is 49.9, compared to U.S. median age of 38.5.

Current per capita income is \$46,810 in the area, compared to the U.S. per capita income of \$34,136. The per capita income is projected to be \$50,480 in five years, compared to \$37,691 for all U.S. households

Currently, 59.0% of the 102,503 housing units in the area are owner occupied; 37.2%, renter occupied; and 3.7% are vacant. Currently, in the U.S., 56.4% of the housing units in the area are owner occupied; 32.3% are renter occupied; and 11.3% are vacant. In 2010, there were 93,371 housing units in the area - 59.9% owner occupied, 34.2% renter occupied, and 5.9% vacant. The annual rate of change in housing units since 2010 is 4.23%. Median home value in the area is \$287,188, compared to a median home value of \$235,127 for the U.S. In five years, median value is projected to change by 1.54% annually to \$310,020.
